Back in May Lynn & Scott Kovack, Mary Beth and Jim Higgins and Ron Egidio and I went to the Herding Instinct test in Lebanon Connecticut. We were the only 6 rottweilers there. A total of 18 dogs were entered. Mostly herding breeds. At the end of the day not only did all 6 rottweilers qualify but in the words of the judges some of the best qualifiers of the day!

Mole, owned by Mary Beth according to one judge had the best technique of all the entries. We all had a great day and learned a lot about herding but most of all I think all the herding people learned a lot about rottweilers, never underestimate the breed.



On May 16, at the Australian Shepherd Club of America (ASCA) trials in Goshen, CT, 5 year old rescue Border collie Folly qualified for her first ASCA Novice B leg with a score of 198 1/2, First Place, and High in Trial. In the afternoon trial, she qualified for another ASCA Novice B leg with a score of 197, First Place, and High in Trial. On the weekend of July 4 and 5, Folly was entered in her very first agility trials. This was also my first agility competition. They were held at Paws N' Effect in Hamden, and the venue was CPE. Folly qualified in all 8 classes, with 5 firsts and 3 seconds, qualified for the 'Perfect Weekend' rosette, and achieved her CPE Level 1 title (CL1). She is now officially: Northwoods Redneck Girl, RN, FDCH-G, CL1 Then, on July 19, at the UKC trials in Hamden, Folly qualified for her first UKC Novice B leg with a score of 195 1/2 in Trial 1. She qualified for a second leg in UKC Novice B at Trial 2 with a score of 197 1/2 and First Place.
